information to be stored then you can select the appropriate radio button on the sign-in page and this cookie will not be used.

You have the ability to accept or decline cookies. Most browsers automatically accept cookies, but you can usually modify your browser settings to decline cookies if you prefer. If you choose to decline cookies then you may not be able to sign in or use the other interactive features of the site that depend on cookies.
